CIA NEWS

TSA's New Restrictions on powders in carry-on luggage:
As of June 30th, 2018, the TSA has limited the size of packages containing powders in carry-on bags of persons entering the USA. All powdered substances such as makeup, baby powder, ground coffee and spices 12 ounces or more **MUST** be packed in checked bags only. Packages of powdered substances purchased post security are not subject to this rule. However if you have a connecting flight into the US, you must place these items in your checked luggage at point of connection prior going through security or if items are placed in Security Tamper Evident Bags (STEBs) at the store of purchase at the airport.
